

Certification Renewal Form Instructions

Page 1:

- Please read, sign, and date the Student Covenant.

Page 2:

- Fill out the Student Information section in full.
- List any responsibilities you have had at your church during the preceding academic year.
- Sign and date at the bottom of the page.

Page 3:

- The “Statement of Certification” box must be checked with your name in the blank.
- The box that states, “This congregation affirmed this student’s involvement...” must be checked.
- Below that box, one or more of the four options must be chosen, and a date must be provided.
- If you choose the option that states, “Adoption of statement of certification above by others (specify below)...” then you must choose one of the options below.
- If you choose the fourth option, “other,” then you must specify who adopted the statement of certification.
- The last box on the page must be checked, stating that you have had a conversation with the person who signed your form about your call to ministry and what it may look like currently and in the future.

Page 4:

- The box at the top of the page must be checked, stating that your pastor or other church leader affirms your need for scholarships through the BGCT.
- Please fill out the pastor information section.
- Provide church name and address.
- List denominational affiliations.
- The pastor or other church leader who filled out the form must sign at the bottom of the page.
- There must be a signature in the “Church Clerk” blank. If you do not have anyone acting as the church clerk, or they are unavailable, any other church leader can sign in this blank.
